**Title - Key - Opus number:** the title of the track performed the tonality of the track and the opus number.

**Composer:** name of the composer of the piece.

**Ensemble - Orchestra - Performer:** name of the ensemble/orchestra who performed the piece.

**Name of production company:** indicate who the financial producer is, who bares the recording costs.

**Year and country of recording:** the year and the country in which the recording did take place.

**Year and country of mastering:** the year and the country in which the recording was mastered.

**Role:** indicate the level of participation of the performer in the recording.

**A** = soloist

**B** = conductor

**C** = orchestra member or choir member.

**Instruments - Vocal:** indicate the instruments played or the vocal contribution. (Soprano, alto, tenor, bass,...)
