DEADLINES FOR DECLARATIONS

Please find below the overview of deadlines for declarations according to specific reference years. Declarations made after the mentioned date will be no longer taken into account for the calculation of rights for a specific reference year. The deadline is activated by the year of the first payment.

ATTENTION: when a declaration was made too late according to the distribution for a specific reference year it is not necessarily too late for the years to come. Recordings can be broadcasted, sold, made public year after year. We recommend you declare all your performances in a timely manner to avoid missing these deadlines.
